All members receive discounts for event booths. Membership includes basic VR design work, creation of an individual QR code and access to the platform and various channels where appropriate. We also offer promotional media support and an interview on our Membership Channel.

Affiliate Programs:

These will work in different ways. There will be affiliate programs for companies that sell/market their products/services on the Earthstock Platforms. Each company will have its own affiliate program. It is assumed that each company will handle the bookkeeping/payment structure for their program.

Affiliate Program Protocols:

Affiliate: After registration a formal sales agreement must signed with all the specifics of products and services offered. Affiliate cost to EarthStock Enterprises and the agreed upon commissions. Upon agreement the annual membership fee must be paid within 30 days for process and QR code creation and uploading to the website and Virtual World platform. This will also include a promotional video on the EarthStock Membership Channel supplied by the affiliate. A video may be created by Golden Road Productions for an additional fee of \$250.
